Sports Club Membership Terms and Conditions

1. Membership Types and Fees

We offer both Rolling Monthly and Fixed-Term memberships. Payments are collected monthly by direct debit on or around the same date each month.

2. Minimum Term (for Fixed-Term Memberships)

Fixed-Term memberships have a minimum commitment of _____ months from the Start Date. After this period, the membership continues on a rolling monthly basis unless cancelled in accordance with these terms.

3. Cooling-Off Period

If you joined online, by phone, or by email, you have **14 days** from the Start Date to cancel for any reason and receive a full refund of any fees paid. If you start using the facilities within this period and then cancel, we may deduct a reasonable amount to cover the days you used the centre.

4. Cancellation after Minimum Term or Rolling Membership

You may cancel at any time after the minimum term (or at any time for Rolling Monthly memberships) by giving **30 days' written notice**. Notice may be given by email, letter, or in person at Reception. Your final payment will cover the 30-day notice period.

5. Early Cancellation (During Minimum Term)

You may cancel before the minimum term ends if you relocate more than 20 miles from the centre, suffer a long-term illness or injury preventing use of the facilities (medical evidence may be required), or if we make a significant change to this agreement that disadvantages you. No additional fees will be charged in these circumstances.

6. Freezing Your Membership

You may request to pause your membership for medical reasons or extended travel. Pauses must be agreed in advance and confirmed in writing.

7. Price Reviews

Our membership prices are reviewed annually in **August**. We may increase your monthly membership fee once per year in August by up to **[e.g. 5% or CPI inflation rate]**. We will give you at least **30 days' written notice** of any increase. If you do not wish to continue at the new price, you may cancel your membership by giving notice in accordance with Section 4 before the new price takes effect.

8. Changes to Fees or Terms

Apart from the annual review in Section 7, we may increase fees after the minimum term or make changes to terms by giving at least **30 days' notice**. If you do not accept a change, you may cancel with no penalty.

9. House Rules

Members must follow our **Health & Safety** rules and behave respectfully toward staff and other members. Serious or repeated breaches may result in suspension or termination (with unused fees refunded if we terminate without cause).
